WILD MAN OF OKEFENOKEE!

It was the year 1935; I was then, barely alive, ten years of age, Growing up in deep south Georgia, Bacon County. Alma was the town, Where I first began to develop a lifetime love affair and a passion for origins; just where do we come from? A question most profound!

Alma lies about 40 miles north of the famous, big Okefenokee Swamp, which, an indian name, is known as the land of "Trembling Earth." Who would ever think, my hometown, as the location, of a famous, American 20th century origins hoax, a pretext, a Pilttdown rebirth?

An Alma dentist, Doctor John R. Dedge, killed several goats before he methodically then selected an imposing pair of sharp goat horns. Dr. Dedge then surgically implanted and fitted them on a low-browed black man, and, put him in a cage, pulled by a car, thusly adorned.

The Doctor and his good friend, the "Wild Man Of Okefenokee," then toured America as a museum attraction, they collecting much money, purporting to be Evolution's Exhibit A, of half man and half beast. Many, who paid to view the freak thought it weird, but also funny!

The dentist and the wild man, traveling from city to city, were as happy as could be until they arrived and struck Evanston, Illinois. The Humane Society raised a row, making him dehorn his money-maker which broke the wild man's heart, and put a crimp in the Dr.'s joy!

Eminent surgeons, all over the country, soon had carefully examined the horned black man, now a "wild man", without finding any suture. experts, were unable to detect how Dr. Dedge had inserted and made fast the goat horns. Could he be a plastic surgeon, of the future?

This is all a true story, arousing then my young curiosity. It is All documented in the Baxley News, at Baxley, Ga., of June 9, 1938, in a news article entitled "An Interesting Family in Old Appling," Written by George D. Lowe, a historical writer, noted on this date.

This true bizarre story, originating in Bacon County, was recounted by the County Historical Society in one of Alma's local newspapers. Perry Streat kindly donated the space to the society, in the paper, and Historical Director, Mrs. Bonnie T. Baker, recorded the caper!

From the dEdge family genealogy in France, came Isaac Dedge; then follows, his son Captain Joseph Gore Dedge, of the Civil War era; Next came his grandson, the dentist John R. Dedge; the latter two Dedge's, were buried in the same plot, in Alma's Rosehill Cemetery.

When as a student, in 1948 at the University of Georgia, in Athens, a visiting Ph.D. scientist, came to campus, urging everyone of us, to study hard, and learn more about our ape ancestry animal, past, as this would enhance our education, and would be a very big plus!

Later a lawyer friend discussed all this subject in detail with me. He was sincere when he suggested, that we had all come from a fish. That's about when I decided, I'd had enough of this talk, and would study hard, and do my own research, before buying that fishy dish.

Also, remember the rest of this pattern, picture puzzle, Pandora's Box, and what some referred to as Nebraska man, "pig in the poke," and the missing link "Java Man" (a mishmash of some orangutan bones discovered by Dr. Eugene Dubois). Man's forerunner- or a big joke?

A lawyer, named Charles Dawson, produced mythical Piltdown Man (now Acknowledged a fraud) from, some chimpanzee jaw fragments of bone. A monument was built to him. His assistant, a Dr. Smith Woodward, attained knighthood — where in the world, has all the truth gone?

Peking Man's claim for fame, the bones, now have all disappeared. The Scopes trial Exhibit A, Nebraska Man drawing based on a tooth of a pig; it's about the first time a pig, ever made a monkey out of a man; but, all of these examples given, are really the truth! Now, the theory of devolution, is, about the reverse of evolution. Where some, thinks we humans, have gradually devolved into monkeys; Emory's Dr. Geoffrey H. Bourne, and, some other scientists, believe downward decline, degeneration, and dehydration, are the real keys.

Attorney William Jennings Bryan, has agreed, a little with Bourne, that monkey and ape may have devolved downward from degenerate man, which is a more plausible theory than man becoming an improved ape. The real issue is, based on all the evidences, where do you stand?

We acknowledge, the second law of science, entropy, does support a downward, degenerative, dying, decadent, deteriorative devolution. Darwin has written a best-seller: *Descent of Man* – declarations; Deen Dissents--to both Darwinian ideas of devolution and evolution and, seemingly, has caused a real full blown scientific revolution!

Whether one chooses, an abrupt appearance, devolution or evolution, the important legal and educational questions are for every student to be exposed to the pro and con of each idea, model or explanation wherever tax-paid textbook curriculums are used by our governments.

John T. Scopes, a biology teacher, stated in court, as a defendant, Never to limit teachers or students, to considering, only one side; He emphasized, the teaching every aspect of every theory, and, then truth, openness, fairness, and academic freedom, will always abide.

Darwin has clearly written, that, in his wildest daydream, he only wanted to demonstrate to everyone that there were two viable views; even evolutionist Clarence Darrow, said, it was bigotry for schools To teach only one explanation of origins, instead of the usual two!

Scopes' lawyer, Dudley Malone, firmly stated, without equivocation, "For God's sake, Let all the children, have their minds kept open, close no doors to their knowledge; shut no door from them." These are words that all of us should hear as they are words well spoken!

Small limited changes, are sometimes called micro-evolution, while others label the tiny changes within boundaries, genetic variation; Its the big unlimited changes, named macro-evolution, that many say contradicts the 2nd law, and, is a macro-debate shaking the nation!

The evolving notion of animals and humans sharing a common ancestor is presented by most evolutionists as all occurring in slow motion; other evolutionists contradict this, by teaching fast rapid events; the verdict in this conflict being a yes and no – land a "gotion!"

Some evolutionists articulate and contend it was achieved so slowly that no one is now living who ever lived long enough to observe it. Other evolutionists say it all happened quickly in fits and starts, That either way you still can't see it, a shell game requiring wit?

Punctuated equilibrium today is the new label for quick big change; Little Tom-Tits often parades and pretends as - feathered peacocks, as some often quote millions and millions of years, to try to hide, the rock of ages, and, a time clock study of the real age of rocks.

It could be monkey into man, or, humans into animals, or, *NEITHER*, As data and evidences, point to a joint abrupt appearance, of each; favorable and unfavorable evidence, as to all models and theories, is the proper standard all public schools should present and teach!

Let's debate young-earth, medium-earth, and, old-earth time clocks, Similarities vs. differences; limited vs. complete change, as, in geographical distributions, vestigial organs, breeding experiments and mutations; providing then, an open, fair, origins study range!

A LITTLE KNOWN STORY ABOUT -- JOHN BIRCH!

John Birch, was a real genuine World War II hero, who aided greatly in the dramatic rescue of the famous pilot Col. James H. Doolittle; He was also a talented interpreter for Gen. Claire Chennault of the "Flying Tigers," but, there is a bit more, --a little known riddle.

Most people will recall hearing of a much publicized society in our country, using and bearing, today, the illustrious John Birch name. It's not the organization's political activity, but, a little known story, that provides a lot of significance to Birch's initial fame.

Reporter Sam Hopkins covered this trial and event in a news feature article dated April 23, 1978, page 3, The Atlanta Journal Magazine; It's all about young John Birch, as a 20-year old student at Mercer University in Macon, which, created another exciting Georgia scene.

One of his distinguished classmates, providing an interview, said, "John Birch was one of the most dynamic personalities I ever knew," that he had "personal magnetism, that he was a born leader, and was capable and gifted without measure," possessed by only, just a few!

At Gore High School in Floyd County, Georgia, he was thusly chosen Valedictorian, meriting graduation, at the very top, of his class; He also won first place, at a field day declamation, and the topic was Patrick Henry's famous Liberty oration, a class act, and, task!

While at Mercer, it was noted, "he made A's almost automatically," And, then finally, "graduated Magna Cum Laude with a B.A. Degree"; Thereafter, at a college in Fort Worth, Texas, he there, completed two years' work in one, and again at the top of his class, you see!

Now, John and twelve other of his fellow young ministerial students later became widely known, at Mercer, as the militant, "Unholy 13"; They publicly, made charges against five respected professors, and, a "Heresy Trial" followed, as amazing in these parts, as ever seen!

Letters were written, outlining, the accusations and issues raised and were mailed out to many, including, over 1,000 Baptist Pastors; Theological liberalism, and, one-sided interpretations favoring Ape Ancestry Evolution, was most of the talk; sparks was flying faster.

Georgia Gov. Eugene Talmadge, extended an invitation, to then famed Texas evangelist J. Frank Norris, to our state, who came, to speak; This helped spur on some of the rhetoric of fire-and-brimstone-type Debates and speeches, in Macon's Municipal Auditorium, to the peak!

The Mercer college president, trustees and the executive committee, The Macon's Baptist Pastors Union, and, many other Georgia citizens became involved in the investigation, a indictment type of charges. Three Ministers were appointed "counsel", for "Unholy 13" brothers.

There was set up a six-member group, acting both as judge and jury, and was composed of exactly three lawyers, and, of three ministers; The trial lasted for ten uninterrupted hours over in Roberts Chapel Located on the Mercer campus. This all caused "quite a large stir."

The chief prosecutor was the Rev. J. Seaborn Winn; and, the accused Professors named were Freeman, Crudup, Smalley, Allen, and Wallace, topics of Christianity, physics, English, journalism, and, biology; Placards were paraded, saying, this was a "Witch-Craft Trial" case.

Wallace was charged, with teaching and implying, that certain bones Of our rear end are ape related; "some babies are born with tails"; A skeleton was introduced into evidence so to show that the "human" tail might be a continuation of the spinal column? This tale fails!

Dr. Crudup, who had been selected, as the most, "popular professor" on the Mercer Campus for at least a period of three years in a row, Was then charged with teaching only a one-sided, slow motion "solar systems evolution," while not adding, other scientific views. Whoa!

Some athletes, threatened to remove the pants, of the "Unholy 13," and then to run them half-naked through the main streets of Macon; Dr. Crudup told all, that young John Birch, was a "dynamic fellow," prevailing upon the athletes, please not to carry out the nude run.

The final verdict was an exoneration for all five of the Professors, But the final written report expressed several timely reservations; It was held, that Dr. Freeman had "made some mistakes," he didn't emphasize "his faith," and shortly thereafter came his resignation.

Chauncey Daley commented to all, that Dr. Freeman, "never overcame the mortal wounds of the affair," and, was this trial really fair? What were the real genuine issues, and questions presented in this scopes-like trial? And, more important, do people, actually care?

Many, most, and, maybe the media, might say, the meat of the Macro-Debate was, issues of, Science vs Religion or Religion vs Religion; When in reality the real question is two views, Science vs Science, an Abrupt Appearance, Devolution, and, Evolution offers a solution!

Most of the trials, heartaches, and, disputes of this kind could in Schools and classrooms be always avoided and absolutely eliminated. If all textbooks, teachers, and curriculums would provide differing Interpretations as to Skeletons, solar systems, fossils. Top-rated!

John Birch, went on to command, 100,000 Chinese guerrillas. He also Won the coveted Legion of Merit citation, and, he died a real hero. Most of the general public, and, pro and con fans of Robert Welch, aren't aware of what some might call Birch's finest hour, you know!

Some of the facts of this "little known story" are further told and Discussed in Dr. Ferrol Sams best seller, *The Whisper of the River*; Peachtree Publishers, in Atlanta, Ga., produced this book, and the Part about the trial of the "Unholy 13," I read it "kiver to kiver!"

NATURE NURTURE NORMS AND FREE WILL!

Nature nurture norms, and, the utilization of a person's free will, Were once upon a time in all the schools, about equally emphasized. Today, free will, has been labeled unscientific and unpredictable. So, in most all current curriculums it is omitted and unauthorized.

All three, deal with a person's behavior and conduct, whether what happens to us occurs from instinct, acts of others, choice or luck. Nature is taught as inherited evolutionary instinctivism, genetics; Nurture, as evolutionary behaviorism, the environment, on conduct.

Free will, is the ability in the minds of humans, to make a choice, And, under the law we are responsible, for the choices, we've made. All citizens are presumed sane, to know the law, thus any criminal acts, committed by us, are presumed products of our will, pervades!

The problem with our overemphasizing characteristics of genetics is That it omits, individual responsibility, puts blame off on others. The same applies, to focusing too much, on society and environment, As this shifts blame to someone else, the community, our brothers.

The truth is both genetics (nature) and environment (nurture) norms are contributing factors as to what happens today in all our lives; But the central important emphasis, should focus on choice and free Will, so that our acts and behavior, good or bad, -ideas,- survive!

Psychoanalyst Erich Fromm has written that most all of, post-Darwin Research, on instinct and behavior, is based on ideas of evolution; The contentions are that war, crime, man's destructive behavior are Phylogenetically programmed, or, based on environmental resolution.

Fromm has written, that many today, such as Dr. Konrad Lorenz, have proclaimed evolution a new God; all worshipping Darwin, the prophet. Lorenz, refers to mutation and selection, as "great constructors," With the true confession, "I believe, I believe." A pagan's profit?

Nietzsche is known as "the child of Darwin," argued that evolution Worked toward, birth of a superman, who was above, obeying the law. Clarence Darrow, in defending both Loeb and Leopold, in the bloody murder of 14-year old Bobby Franks, used nature-nurture awe & jaw!

Leopold's idol had been Nietzsche; He thought he too was a superman Above the laws. Darrow, argued to the court: "This terrible crime was inherent in his organism and came from some past ancestor," or from training and education, after his birth. No reason or rhyme!

Pediatrician Benjamin Spock, has said: "Crime is not the fault, of Criminals, but of society." And, our Attorney General Ramsey Clark Said: "We are not yet so far from the jungle that self-preservation has ceased to be our basic instinct." These words, you must mark!

Inner City Mother Goose (Simon & Schuster), used at one time in the 3rd grade, and reads: "Jack be nimble, Jack be quick snap the Blade and give it a flick; grab the purse, its easily done, just For kicks, just for fun, plunge the knife and cut and run." Sick??

Situation Ethics, co-authored by Joseph Fletcher, page 13 advises, "In some situations theft is the right thing to do." Now, if youth are told they are animals and its o.k. to steal, then drugs, crime, permissiveness, blaming others all follows, and become their truth!

Values Clarification, as, authored by Simon, Howe and Kirschenbaum, provides techniques and strategies of doing "whatever feels good." Values and ideas of right and wrong, and of "moralizing adults," is taboo! Only prizing, cherishing, and choosing freely, is the food.

Those, "forced-choice ladder," "privacy circles," "epitaph," and, "Obituary," strategies, have options, of pre-marital sex & suicide. And, strategy Number 50, "Alligator River," has rape as a solution? "Number 48, "The Fallout-Shelter Problem," might sanction homicide!

Students are encouraged, to choose one of several options, some of which, if done in real life are illegal, violate the Criminal Code. They might conclude, that school officials, and, curriculum approve their prizing of drugs, theft, and affirming all this illegal load.

What really should be brought to their attention are cases, such as *United States v. Holmes* (26 Fed. Cas. 360), an unusual, 1842 case, where, the captain and crew, sacrificed lives of their passengers, drowning them in water and foam; surely, this was way, way off base.

Now, it's true that the ship *William Brown* was leaking and sinking and they plead in good faith, they were trying to lighten the load; but the court ruled on "Homicide by Seamen," they could not, claim Exemption, from drawing straws, from the common lot, of the abode.

The crew was prosecuted for homicide, tossing victims overboard and Sacrificing lives of others, the captain, put in the penitentiary. This case demonstrates, we cannot choose freely, to play fast, and, loose with these homicide games. Let's obey the law, this century!

In summary, curriculums and school textbooks, must reemphasize free Will; that is we make choices, and, are responsible for those made. We should deemphasize nature, nurture, norms as to all our conduct. Using the idea of genetics and the environment to blame, must fade.

Teaching in classrooms, as to theories other than animal evolution, Is in order, and, a good solution. Also, ideas of right and wrong, all outlined in our juvenile and criminal codes, are most in order. Crime curriculum causes & cures must be considered before too long!

AM I MY KEEPER'S BROTHER?

All of us animals: monkeys, apes, chimps, orangutans, and baboons, For the most part, we will generally, more or less, say and agree that from our lowly perspective, we have a close, family affinity, and just about the same lower animal, but never a human, pedigree.

What none of us can really contemplate, weave, conceive or believe is for some professors and intellectuals, someone and then another to haul off, and, make wild and wooly speculations and predictions, that, we may, literally and fundamentally, be our keeper's brother.

Now, with kindness toward all, we ought to be our brother's keeper. This message was given to most of us; words, of our beloved mother. However, everyone knows, it's a bunch of non-science and non-sense, to suggest without any proof, we are actually our keeper's brother.

Biologically, genetically, and scientifically we all are different; A review of the evidences within biology clearly makes this demand, separate and distinct, past and present, are humans and we animals; On this, we steadfastly insist and without any fear take our stand.

Limited horizontal changes of all, are obvious, and we acknowledge, but complete changes of us into man, or, humans into us, we say no, from the fossil evidence in geology, paleontology, laws of science, it appears crystal clear to most all; this evolution just ain't so!

Ape ancestry animalistic allegations, about us evolving to mankind, are seemingly so specious shallow, sheer shortsighted speculations. An original, simultaneous abrupt appearance of both men and monkeys Provides us a much more logical and serious scientific evaluations.

In promoting only macro-evolution, Dunbar & Waage, in *Historical Geology*, 3rd edition, 1969, and quoting Gaylord Simpson, states: "No further proof is necessary, for anyone reasonably free of old illusions and prejudices." Thus, this is the poor students fate!

H. J. Muller and other biologists have now distributed, their own Manifesto to many Boards of Education so designed to censor other credible alternative, scientific views of origins. They wanted to suppress all unfavorable data. Don't want you, to learn further!
