This agreement made and entered into by and between CHICK-fil-A, Inc., hereinafter referred to as Franchisor and Owners, Green Park Restaurant, hereinafter referred to as franchisee, on this the 11th day of July 1964.

Now for and in consideration of the sum of One dollars and other good and valuable considerations including the mutual promises and covenants herein contained, it is hereby agreed;

1. That franchisor hereby grants to franchisee the right to sell at retail CHICK-fil-A meats, breadings and pickles for a term of 10 years under the name of CHICK-fil-A;
2. That franchisee shall purchase from franchisor or a dealer authorized by franchisor all meats, breadings and pickles used in the preparation of CHICK-fil-A and sold as CHICK-fil-A; together with all equipment used in the preparation of CHICK-fil-A and CHICK-fil-A sandwiches as required by franchisor;
3. That franchisee shall not sell CHICK-fil-A except as prepared to the exact specification of CHICK-fil-A, Inc., not varying to any degree without prior approval of franchisor in writing;
4. That franchisor shall recommend to franchisee programs and advertising to promote the sale of CHICK-fil-A and shall make available for purchase by franchisee advertising materials such as table tents, caps, menu clip-on, inside, and outside advertising signs. Franchisee shall not sell or offer for sale foods prepared as CHICK-fil-A without advertising same as CHICK-fil-A;
5. That franchisor shall provide a representative of CHICK-fil-A, Inc., for a period of 2 days at the commencement of operation by franchisee under this contract for purpose of instructing franchisee in the preparation and selling of CHICK-fil-A, Inc. products;
6. That franchisor shall without charge serve as promotion and marketing counselor to franchisee for the promotion and selling of CHICK-fil-A, Inc. products;
7. That franchisee shall maintain at all times during the life of this agreement public liability insurance protecting CHICK-fil-A, Inc., from liability to the public or any member thereof from negligence arising out of the production or sale of CHICK-fil-A, Inc. products at the location of this franchise said policy shall have a limit of not less than \$25,000.00;
8. It is expressly understood that this franchise is not transferable without the express written consent of franchisor and

shall not be valid except on the premises of Green Park Restaurant located at and known as Highway No. 1 in the city of Alma, Georgia;

9. It is expressly understood between the parties hereto that this instrument conveys no interest in or to CHICK-fil-A, Inc. or any trade mark or trade name of CHICK-fil-A, Inc., and shall not restrict or deprive franchisor from granting other CHICK-fil-A franchises to any other person, firm or corporation at any other premises or locations whatsoever.

10. Should the franchisee desire to cancel this contract franchisee shall give franchisor three months written notice in advance. Franchisor shall have the right to cancel this franchise upon three months written notice in advance. In event this franchise is terminated, franchisee shall remove all advertising signs, advertising that location as selling CHICK-fil-A, Inc. products with 30 days from the termination of this franchise. Should franchisee fail to remove said signs within time herein specified then franchisor is hereby given the right to enter upon said premises without process of law or liability and remove said signs and that franchisee shall pay to franchisor the cost of removing said signs.

11. That as a part of the consideration of this contract franchisee agrees that franchisee shall not prepare or assist in the preparation of boneless chicken for sale either at wholesale or retail for a term of 12 months from the date of such cancellation or termination of this agreement within the State of U.S.
